

Calypso Mango Facebook Competition Terms and Conditions

PERFECTION FRESH AUSTRALIA, 10th November 2017

1. Calypso Mango Facebook Competition (**Competition**) is subject to these terms and conditions. Details of the Competition and a copy of these terms and conditions are available at the Website page at <http://www.calypsomangoes.com.au> or on request from Perfection Fresh Australia.
2. The promoter is Perfection Fresh Australia Pty Ltd (ABN 75 127 389 682) of PO Box 98, Sydney Markets NSW 2029 (Promoter).
3. The Competition commences at 11.00am Australian Eastern Standard Time (AEST) on 14th November 2017 and finishes at 11.59pm on 21st November 2017 (Competition Period).
4. The Competition is a game of skill, requiring entrants to count or guess the number of mangoes in the produce display.
5. The first 100 Entrants to comment on the post with the number of mangoes in the display with a number closest to the right amount (+/-5) will win a Prize.
6. Each entrant that wins a prize will win a Calypso Cheeky Mango Cutter, with a retail value of \$20.
7. Entrants can only enter once in the Competition Period.
8. The Competition is only valid during the Competition Period. The Competition details are correct at the time of publication of these terms and conditions but may change (at the discretion of Perfection Fresh Australia) at any time. Perfection Fresh Australia will post any changes to these details (including these terms and conditions) on its Calypso Mango Facebook page.
9. Entry is only open to Australian residents aged 18 years or over. Employees, contractors, consultants and agents (and their immediate families) of Perfection Fresh Australia, its licensees and marketers are ineligible to enter the Competition.
